

2022 Barber County Local Alcoholic Liquor Funds

Grant Application

Kansas law requires that taxes be collected on alcohol sold. The revenue is used for State, County and local projects for the benefit of our communities. The Barber County Commission will make the final decision on the distribution of County special alcohol funds for projects. Kansas law has specified how these funds may be used. KSA 79-41a04(e) states, in part "...Monies in the special alcohol and drug programs fund shall be expended only for the purchase, establishment, maintenance or expansion of services or programs whose principal purpose is alcoholism and drug abuse prevention and education, alcohol and drug detoxification, intervention in alcohol and drug abuse or treatment of persons who are alcoholics or drug abusers or are in danger of becoming alcoholics or drug abusers. Monies in the special parks and recreation fund may be expended only for the purchase, establishment, maintenance, or expansion of park and recreational services, programs, and facilities."
